Item I. Opening of the meeting

The meeting was officially opened by the Chairperson. MC members and JS staff were introduced.

Item 2. Adoption of the agenda (D)

The Monitoring Committee members approved the agenda with the following changes:

- Originally planned item I. Words of welcome was deleted.
- Additional information point was added as item no. 12 Infrastructure in tourism projects.

During the meeting the point related to Programme implementation plan for 2022/2023 (originally planned item 7.) was moved to the beginning of the second day.

Item 3. Monitoring Committee Rules of Procedures (D)

The Rules of Procedure was presented. The presentation included the tasks and responsibilities of MC members, structure of the MC, Voting, Conflict of interest and organising MC meetings.

- As result of discussion Points 10, 12, 13 and 15 of Article 3 were changed clearing out the
 nomination of observers and possibility of participation of observers in MC meetings. It
 was highlighted and agreed that the JS with drawing up a proposal shall support the
 Chairperson in deciding on the participation of ad hoc experts and observes in MC
 meetings.
- Article 6, point 3 that concerned the possibility of online participation in on-site MC meetings was deleted.

The Rules of procedures was approved with the indicated changes.

Item 4. Programme Manual (D)

The Programme Manual was presented. The presentation included information on the preparation process of the Manual and detailed information on the content of the document.

- Ch. III/1/1.2.: Information on limits for project prolongation was deleted in the project types table. Footnote with reference to the relevant part of the Manual was added.

The Programme Manual was approved with the indicated changes. No comments to the Programme Manual were received from the EC prior to the MC meeting.

Item 5. Project selection criteria (D)

The Project selection criteria were presented. The presentation included information on the assessment process, admissibility and eligibility checks, state aid assessment, quality assessment and strategic projects.

In the selection criteria (Annex 6 to the Programme Manual) the wording related to simplified cost options was adjusted.

The selection criteria were approved as proposed with the indicated technical change.

Online workshop for MC members on project selection will be organised by the JS approximately one month before the project selection by the MC, i.e. the MC meeting.

It was confirmed that the selection criteria were submitted to the EC and one remark was received from the EC prior to the MC meeting to the project selection criteria on relevance of the project objective to the corresponding Specific Objective. The remark was included to the criteria.

Item 6. Scope of the first call for proposals (D)

The Scope of the first call for proposals was presented. The call will be open for regular project applications (including operations of strategic importance) in all Measures without financial limits.

The scope of the first call was approved as proposed.

Item 7. Online Application Form (I)

The Application Form in the WOD2021 application system and the Supplementary Application Form were presented.
