The Minutes from the written procedure of the Monitoring Committee

13 June 2024 - 27 June 2024

In accordance with the Article 9 of the Rules of Procedures of the Monitoring Committee, the written procedure was held from 13 June 2024 until 27 June 2024. The following issues were subject to the Monitoring Committee decision:

Selection of projects submitted under 1st Small-scale projects call for proposals;

Background information

According to the INTERREG South Baltic Programme implementation plan for 2024-2025, approved during the 3rd Monitoring Committee meeting, the written procedure on the selection of projects submitted under the 1st Small-scale projects (SSP) call for proposals should be held between 13 June and 27 June 2024.

The 1st SSP call for proposals of the Interreg South Baltic Programme 2021-2027 took place between 22nd February and 21st March 2024. During the call, applicants submitted 11 applications under five Programme Measures. All submitted proposals passed the admissibility and eligibility check and were subject to quality assessment, in line with the Terms of Reference for the 1st Small-scale projects call for proposals.

Recommendation

In total, **7 out of 11 proposals met the quality assessment thresholds** set in the Programme. The sum of total budgets corresponding to the projects passing the thresholds amounts to 1,347,333.00 EUR (1,077,866.40 EUR ERDF).

Decision

- Altogether 5 Small-scale projects have been selected for funding by the Monitoring Committee of the Interreg South Baltic Programme 2021-2027 in the frame of the 1st Small-scale call for proposals.
- ▶ In total the allocated financial resources to these Small-scale projects amount to 947,341.00 EUR (757,872.80 EUR ERDF)
